



## Public Space Protection Order Consultation 2017

This report outlines the quantitative findings from the Public Spaces Protection Order Consultation that took place from 4<sup>th</sup> September to 16<sup>th</sup> October 2017.

### Number of Responses

- A total of 408 responses were received to the consultation:
  - Poole Town and Holes Bay – 281 responses
  - Ashley Road and surrounding areas – 77 responses
  - Alexandra Park – 50 responses

### Demographics

- Most respondents said they were Poole residents who lived in or close to the proposed PSPO areas and/or visited the proposed areas
- More females responded than males
- Most respondents were from a 'White British' background
- Most respondents were aged 35-64

### Summary Findings

#### Poole Town and Holes Bay

- Respondents felt rough sleeping and begging were the key problems
- Respondents agreed most with Measure 5 (*illegal substances*) and disagreed most with Measure 4 (*rough sleeping*)

#### Ashley Road and Surrounding Areas

- Respondents felt anti-social behaviour, street drinking and drunkenness, nuisance behaviour, and begging were the key problems
- Respondents agreed most with Measure 5 (*illegal substances*) and disagreed most with Measure 3 (*begging*)

#### Alexandra Park

- Respondents felt drinking and drunkenness was the top problem in Alexandra Park, followed by drug use, anti-social behaviour, and nuisance behaviour
- Respondents agreed most with Measure 5 (*illegal substances*) and disagreed most with Measure 4 (*sleeping overnight*)

## 1 Background

The Council consulted on proposals to introduce and revise public space protection orders (PSPOs) in three parts of Poole: Poole Town Centre and Holes Bay, Ashley Road and surrounding areas, and Alexandra Park.

The orders were proposed to help deal with several problems including:

- anti-social behaviour
- drug dealing and taking
- rough sleeping
- shoplifting

## 2 Target Groups

The consultation targeted the following stakeholder groups:

- Poole residents
- Local businesses
- Local organisations
- Any other interested stakeholders

## 3 Data Capture and Analysis

The surveys were designed in Snap (survey design software). The paper forms returned were scanned by the Corporate Research Team. These were kept in a locked cupboard and will remain securely held until they are destroyed confidentially until 6 months after the final outcome of the consultation is announced.

Online responses were downloaded into an Excel file and imported into SPSS (statistical analysis software) for analysis purposes. The data was checked and verified in preparation for analysis. The data is held in the Corporate Research Team's secure area.

Quantitative analysis was carried out using SPSS to identify the frequencies for each question.

## 5 Findings

This section summarises the results of the surveys for Poole Town and Holes Bay, Ashley Road and surrounding areas, and Alexandra Park. Please note that this report only outlines the quantitative findings - the Safer Communities Team have analysed and written up the qualitative findings separately. For each question, the base is reported to show the number of people responding to that question.

## 5a Poole Town Centre and Holes Bay Findings

There were 281 responses to the PSPO proposals for Poole Town Centre and Holes Bay.

### Respondent Profile

This section summarises the demographic characteristics of respondents to the 'Poole Town Centre and Holes Bay' survey.

- **Respondents:** Over half of respondents said they were 'A Poole resident who lives in or close to the proposed PSPO area' (n=146), while just under half of respondents said they were 'Someone who visits the Town Centre' (n=136).

## Do you agree with the proposed PSPO Measures for Poole Town Centre and Holes Bay?

This section summarises the extent to which respondents agreed or disagreed with each proposed PSPO measure for Poole Town Centre and Holes Bay.

Respondents agreed most with **Measure 5** (n=230), i.e. “No one can possess, supply or use illegal substances or so-called ‘legal highs’. People will be required to surrender any such substances in their possession when asked to do so by a Constable or Authorised Officer”.

Respondents disagreed most with **Measure 4** (n=166), i.e. “No one can sleep overnight in a car park operated by Borough of Poole or any private company. This will also apply to sleeping in the doorways of shops, churches and offices, or in any vehicle not designed for the purpose of sleeping.”

## 5b Ashley Road and Surrounding Areas Findings

There were 77 responses to the PSPO proposals for Ashley Road and surrounding areas.

### Respondent Profile

- **Respondent:** 66% of respondents said they were 'A Poole resident who lives in or close to the proposed PSPO area' (n=51), while just over half of respondents said they were 'Someone who visits Ashley Road' (n=39).

Respondents agreed most with **Measure 5** (n=68), i.e. “No one can possess, supply or use illegal substances or so-called ‘legal highs’. People will be required to surrender any such substances in their possession when asked to do so by a Constable or Authorised Officer”.

Respondents disagreed most with **Measure 3** (n=23), i.e. “No one can sit or loiter in a public place with a container used to collect money for the purposes of begging.”

Respondents agreed most with **Measure 5** (n=45), i.e. “No one can possess, supply or use illegal substances or so-called ‘legal highs’. People will be required to surrender any such substances in their possession when asked to do so by a Constable or Authorised Officer”.

Respondents disagreed most with **Measure 4** (n=14), i.e. “Without permission no one can sleep overnight in the Park between the hours of dusk and dawn.”
