

Dorset at a glance


- The health of people in Dorset is good compared to the England average. The rate of early death from cancer is better than England as whole, but the rate of new cases of malignant melanoma skin cancer is worse.
- Life expectancy is higher than the England average.
 However, life expectancy for men in the most deprived areas is nearly 5 years less than for those in the least deprived areas. For women the gap is nearly 4 years.
- Early death rates from cancer and from heart disease and stroke have fallen over the last 10 years and are both lower than the England average.
- The proportion of Reception year children classified as obese is lower than the England average. The proportion of women who smoke during pregnancy is higher than the England average.
- The estimated rate of adult obesity in Dorset is better than the England average. However, there are over 18,000 people diagnosed with diabetes every year, which is above the England average.
- The rate of death or serious injury on Dorset's roads is high compared to England as a whole, with over 270 people killed or seriously injured each year.
- The Dorset Local Area Agreement has prioritised tackling levels of physical activity, smoking and tobacco control, healthy weight, alcohol misuse and teenage pregnancy.




Deprivation: a national view



Health inequalities: changes over time



Trend 1 compares rates of death, at all ages and from all causes, in this area with those for England.


Trend 2 compares rates of early death from heart disease and stroke (in people under 75) in this area with those for England.

Trend 3 compares rates of early death from cancer (in people under 75) in this area with those for England.


Trend 2: Early death rates from heart disease and stroke



Trend 1: All age, all cause mortality




Trend 3: Early death rates from cancer


